



Fact Sheet – “287(g)” Agreements

287(g) agreements define the scope and limitations of the authority to be designated by DHS to the state or local law enforcement entity. They also establish a supervisory structure for the participating officers and prescribe the agreed upon complaint process governing officer conduct during the life of the agreement. The numbers of officers from a department who participate and the range of functions they are authorized to perform typically are limited.

Although the parameters for local police participation should be clearly delimited by the agreement, many advocates have serious concerns about these agreements in operation. There is little, if any, monitoring of these programs to restrict racial profiling and there is no auditing of these programs to assess their costs and benefits.
